

TERMS AND CONDITIONS OF THE PROMOTION: BONANZA V – ZEBRA DATA TERMINALS

GENERAL PROVISIONS AND DEFINITIONS, PRIVACY POLICY

These Regulations define the terms and conditions of the "Bonanza V" Promotion.

1. The Organizer of the Promotion is Koncept-L S.A. with its registered office in Warsaw, address: ul. Wenecka 12, 03-244 Warsaw, entered into the Register of Entrepreneurs of the National Court Register by the District Court for the Capital City of Warsaw in Warsaw, XIII Commercial Division of the National Court Register, under the number KRS 0000306428, NIP 526-21-03-850, with share capital of PLN 504,000.00 (paid up in full), e-mail address: koncept@koncept-l.pl, hereinafter referred to as the "Organizer".
2. General terms of cooperation, indirectly related to this Promotion, including: - general terms and conditions commercial cooperation and use of the B2B Koncept-L S.A. System can be found at www.koncept-l.pl
3. The administrator of your personal data is Koncept-L Spółka Akcyjna, based in Warsaw, 03-244 Warsaw, 12 Wenecka St. Consent to participate in the Promotion is tantamount to acceptance of the processing of your personal data for the purposes necessary for the Promotion. Your personal data (company name, first and last name, and e-mail address) may be shared with Zebra Technologies, for the purpose of proceeding with the Promotion. The legal basis for the processing of your personal data, is Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC.

RULES OF PROMOTION

1. The promotion is dedicated only to Koncept-L S.A. Partners operating in the European Union.
2. The promotion lasts from February 24th until June 30th, 2025 or until the stock of prizes runs out.
3. The offer applies to new orders for specified Zebra Technologies branded devices described below, completed and invoiced by June 30, 2025. In the case of current unavailability of the devices included in the Promotion, the bonus will be charged on the basis of a written order confirmed by the Customer, the execution of which will take place on the date agreed upon between the Customer and the Koncept-L S.A. Salesman.
4. **For a one-time purchase of a minimum of three Zebra Technologies TC22 or TC27 data terminals, the Partner receives a quota reward of PLN 40 for each device - paid in the form of an Allegro voucher in the case of Customers operating in Poland and Amazon vouchers for Customers operating abroad.**
For a one-time purchase of a minimum of three Zebra Technologies MC34 data terminal, the Partner receives a reward of PLN 50 for each device - paid in the form of an Allegro voucher in the case of Customers operating in Poland and Amazon vouchers for Customers operating abroad.
The models of data terminals covered by the Promotion can be freely completed within a single order, so they are subject to the calculation of an adequate bonus.

5. Currency conversion is carried out according to the average exchange rate of the National Bank of Poland on the day preceding the date of issuance of the commercial document.
6. The rewards will be given in the form of an Allegro voucher in the case of Customers operating in Poland and Amazon vouchers for Customers operating abroad, based on a summary of purchases made from February 24 to June 30 this year.
7. Returns or corrections to the order result in an appropriate reduction of the prizes obtained on its basis, on the terms as of the date of issuing the correcting document.
8. Prizes are shipped to the address provided in the Clients profile, by courier or by post at the expense of Koncept-L S.A.
9. Liabilities arising from the possible charge of income tax on received rewards are by the side of the Partner - Promotion Participant.
10. The Promotion also covers purchases under special terms and conditions granted by the manufacturer, Zebra Technologies.
11. The Promotion does not cover purchases under Zebra Technologies' demonstration device program.
